Vice Chair Smith called the meeting to order.

#### **Consent Items**

Vice Chair Smith noted there was one consent item on the agenda, the Approval of Minutes for the May 16, 2007 meeting. He stated that if there were no objections or corrections to the minutes, the minutes would stand as approved. There were no comments and the item was approved.

#### **Discussion Items**

Vice Chair Smith stated that the committee had reviewed the proposed Schedule of Board of Trustees Meetings for the years 2007 and 2008 at the previous May meeting, and the schedule was now presented for action. He reminded trustees that at the last meeting in response to a request from the Lt. Governor, the committee asked the Chancellor to coordinate the meeting schedule so that it did not conflict with the meetings scheduled by the Regents of the University of California. Chancellor Reed reported that the University of California would not make any changes to their schedule, and that CSU was able to arrange the schedule so that there would be no conflicts for the January, March and July meetings, providing the committee approved a one-day meeting in July. However, the Chancellor said, the May, September and November meetings of the board do conflict with the University of California's schedule. He reported that the meeting scheduled for October 25 meeting had been cancelled. The Chancellor reiterated his commitment to the Lt. Governor to work together with the University of California to resolve conflicts in the 2009 schedule. Lt. Governor John Garamendi thanked the Chancellor for his efforts and assured that he would discuss the matter with UC President Dynes. He stated that the
